Regulating the Purchase/Sale of Homes and Registration/Titling Issues

Over the last four decades of HCD involvement in regulating the purchase/sale, registration and titling of manufactured homes, the involvement of owners has been minimal. As a result of the "Great Recession" and other factors (resident deaths, resident inability to sell units, etc.), owners must know when and how it is legal to purchase and sell, and when and how they are required to transfer title to themselves and/or purchasers. The seminar will be immediately applicable and helpful to unravel the mysterious labyrinth of acquisition, sales, registration, titling and financing limitations. *(Terry Dowdall and Ron Javor)*

Risk Management/Insurance Defense

Many manufactured housing community operators don't have backgrounds in commercial insurance and the densely complex body of law that applies only to our industry. Join us and learn practical tips and basic legal principles concerning risk management, insurance defense of liability claims on general liability policies, errors and omissions coverage and more. Whether you operate a "five-star" community or a rural trailer court, the risk of adverse claims and lawsuits abound. We can help. *(Michael Mihelich, Julie Rubin and Phil Woog)*

Sex Discrimination in the Workplace—What Community Owners and Managers Need to Know

This panel discussion will provide both owners and managers with the necessary tools to recognize sexual harassment in the workplace and implement the steps to remedy and prevent such harassment. We will discuss recent developments in federal and state law, examples of illegal behavior, and measures that should be taken to prevent the occurrence of sexual harassment in the workplace. Participants will receive a certificate of training which satisfies the requirements of California law for sexual harassment training every two years for managers and supervisors who are employed by employers with 50 or more employees. *(William Hart, Chad Casenhiser and Mindy Parish)*

Update on New Laws

The Pilot Conversion Program begins with applications being submitted beginning January 1, 2015. Come listen and learn how to become a part of this new opportunity to convert your electric and gas systems to direct service.

What Do You Mean I'm Not Covered?

Owning and operating a manufactured housing community is becoming more complicated in California's current business climate. This is also true when selecting insurance coverage for your community. Don't let your lack of understanding regarding "insurance" place you in a position where you suffer an uninsurable loss. Become a better insurance risk manager for your community's operations.
