2020 MCM TOPICS

JUNE: Fair Housing & MRL: How to Stay in Compliance with Both!

This seminar will focus on keeping parks in compliance with current Fair Housing Law while addressing the balance needed to stay in compliance with the Mobilehome Residency Law (MRL) simultaneously. There have been significant changes to Fair Housing Law in California in the last year, as well as new guidelines provided by HUD on the issue of service animals. This seminar will be conducted by a Manufactured Housing Communities industry expert and a Certified Fair Housing Specialist. Attendees will receive a *CERTIFICATE OF ATTENDANCE* at the completion of the seminar.

JULY: Mobilehome Residency Law Compliance - Forms: From Rule Violations to Eviction

2020 MCM is all about COMPLIANCE. This seminar will focus on Business Best Practices to stay in compliance with the MRL when issuing notices, creating a tenancy, or working towards an eviction. We will distinguish which forms need to follow MRL service requirements.

AUGUST: OSHA Compliance and What to Expect During an HCD Inspection

This two-part seminar will be half-day spent with a Certified OSHA Inspector giving tips and answering questions on how to stay in OSHA compliance. The second half of the day will be spent with an HCD expert letting you know what to expect during an HCD inspection and how to avoid citations and penalties.
