SUBJECT: HCD Permit Requirements - Alterations or Conversions

This Information Bulletin (IB) is issued to clarify the Department of Housing and Community Development's (HCD) permitting and inspection authority¹ for the alteration² or conversion to the following units³ in California:

- Manufactured Homes⁴
- Mobilehomes⁵
- Multifamily Manufactured Homes⁶
- Special Purpose Commercial Modulars⁷
- Commercial Modulars⁸

Pursuant to the Manufactured Housing Act of 1980⁹ and regulations¹⁰, **HCD has the sole authority to conduct inspections to obtain insignia of approval**¹¹, or for permit issuance and inspections of alterations, conversions, or the change of use to units.

Examples of conversions includes changing the use, building type, or occupancy classification of a manufactured home/mobilehome (MH), or commercial modular, such as converting from a commercial modular to mobilehome, or converting a commercial modular from a "B" occupancy classification to an "A" occupancy classification.

Unit owners, or their agents (e.g., General Manufactured Housing Contractor (C-47)), intending to alter or convert a unit, must submit an Application for Alteration or Conversion (HCD MH 415) to HCD prior to commencing work.

The following Manufactured Home/Mobilehome Alterations Guidelines provides information on the HCD's permitting process, assist in determining what constitutes¹² an alteration to a MH, and assist in identifying when an HCD MH 415 is, or is not, required. The HCD MH 415 can be obtained from an HCD Field Office or on HCD's website through the following link. When multiple alterations are proposed to the same MH such
